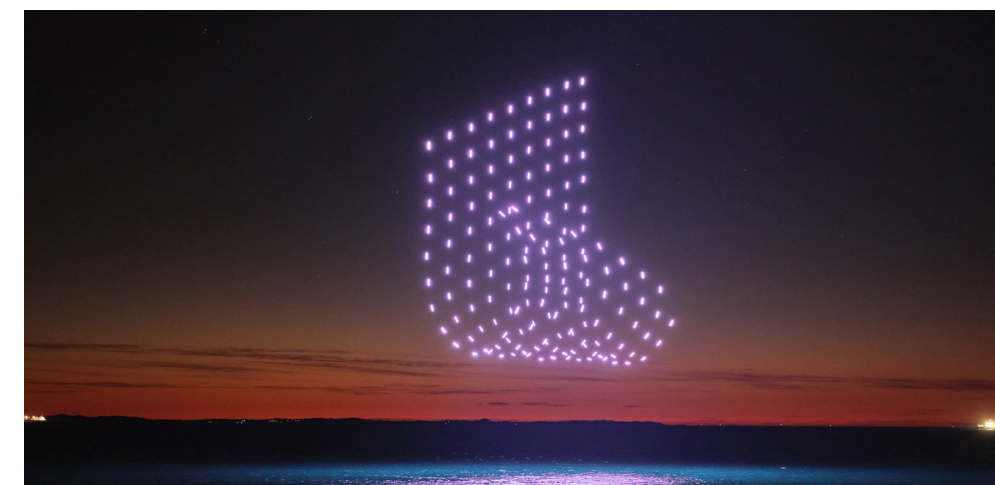

Similarly, we are active in the aerospace (and remotely piloted aircraft or 'drone') sector and regularly advise on commercial and regulatory matters. We have been recognised for our long-term leadership in relation to the Australian drone industry. The firm was also a finalist in Aviation/Aerospace Australia's Excellence in Innovation (SME) award for 2024. The firm is also a corporate member of both the Henderson Alliance, AIDN and WiDA organisations.

In 2021, the firm assisted a drone operator in commercial work enabling WA's first large-scale drone light show for Ilona McGuire's "Moombaki", the flagship work as part of the Crossing 2021 edition of the Fremantle Biennale. The light show featured a fleet of 160 choreographed drones, accompanied by a rich soundscape, telling the stories of Whadjuk Nyoongar Country and its Traditional Owners. The drone fleet took part in a series of performances over 8 nights in 3 locations over the ocean and waterways of Perth. Subsequently, as part of First Lights, the team have worked across Australia and internationally facilitating works of this type.
